





eMaryland Marketplace Advantage (eMMA) launched in July 2019. eMMA is the online procurement system that provides registered vendors with easy access to State procurement information and automated notification of new procurement opportunities.

eMMA allows vendors the ability to:

- Complete the self-certification to become a certified Small Business;
- Register to become a certified Veteran Small Business Enterprise (VSBE) Business;
- Receive automated notifications of bid opportunities based on your firm's eMMA set-up;
- Search for contracting opportunities;
- Submit bids electronically (when applicable); and,
- Obtain bid results online.
